Claim for Exemption
Kuleana Land
Revised Ordinances of Honolulu ("ROH") § 8-10.29

1. Requirements to Qualify for Kuleana Land Exemption:

- a. The claimant must be a lineal descendant of the person(s) to whom the kuleana land was originally granted. You must provide proof of your genealogy-either through the Office of Hawaiian Affairs ("OHA") or via a court order.
- b. The land must be confirmed as "kuleana land," as defined in ROH § 8-10.29(c). You must submit both the Land Commission Award ("LCA") number and the Royal Patent ("RP") number for the parcel, along with supporting documents to Real Property Assessment Division ("RPAD") for verification.
- c. The claimant is responsible for the costs associated with obtaining evidence pursuant to ROH § 8-10.29(b)(2).

2. How to File a Claim:

- a. Deadline to file a claim is on or before September 30 preceding the applicable tax year. Claim forms sent by mail must be postmarked on or before the September 30 deadline.
- b. This form is available for download at: realproperty.honolulu.gov. Claimant may mail or hand-deliver the claim form, along with supporting documents to one of the two RPAD offices listed below. This claim cannot be filed by fax or email. To receive a file-stamped copy, include a self-addressed, stamped envelope with your submission.

3. Ownership Changes:

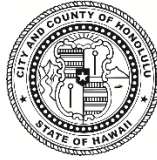
- a. If the parcel with a kuleana exemption was purchased or transferred to a new owner, the new owner must file a new claim for the exemption on or before September 30 preceding the applicable tax year.
- b. Proof of genealogy is required.
