

## **REAL PROPERTY STORM DAMAGE RELIEF**

### ***Remission of Property Taxes (ROH § 8-4.2)***

**Deadline: June 30, 2026**

Was your real property damaged during the March 2026 storm? You may qualify for a remission of real property taxes.

### **STEP 1: DOCUMENT DAMAGE**

- Take photos/videos BEFORE, DURING, and AFTER cleanup
- Capture damage before removing debris when possible
- Keep repair estimates, invoices, and contractor reports
- Save insurance claims and documentation

### **STEP 2: SUBMIT YOUR CLAIM**

- Completed Remission of Taxes (Natural Disaster) Form (BFS-RP-P48A)
- Supporting documentation (photos, estimates, insurance, etc.)

### **IMPORTANT REQUIREMENTS**

- Applies ONLY to real property (land and structures)
- Does NOT include personal property (furniture, vehicles, crops, equipment, etc.)
- Incomplete submissions may delay or affect eligibility
- All claims are reviewed after the deadline

### **HOW TO SUBMIT (No Email or Fax)**
